**STIPULATION AND ORDER
REGARDING INTEL DISCOVERY INTO AMD EVIDENCE PRESERVATION**

WHEREAS, on November 7, 2008, this Court held a status conference regarding Intel's discovery into the sufficiency of AMD's evidence preservation and document productions;

WHEREAS, the Court directed the parties to establish a schedule for future actions and deadlines relevant to these issues; and

WHEREAS, the parties have met and conferred regarding the scheduling of such matters and have reached agreement.

NOW, THEREFORE, IT IS HEREBY STIPULATED BY AND AMONG AMD AND INTEL, THROUGH THEIR RESPECTIVE COUNSEL AND SUBJECT TO APPROVAL OF THE COURT, AS FOLLOWS:

1. In accordance with the schedule below, the parties shall continue to act in good faith to engage in informal disclosure of information, including, but not limited to, witness interviews, document productions and, as agreed to between the parties, AMD's provision of written summaries or other specially-prepared data relevant to the matters in issue as specified in the Court's Summary Chart, and as discussed at the September 11, 2008 and November 7, 2008 hearings and during the informal disclosure of information (hereafter, the "Informal Information Disclosure Period").

2. Subject to the Court's approval, the parties jointly propose the following dates for the completion of certain actions relevant to the Informal Information Disclosure Period and the subsequent formal discovery into the sufficiency of AMD's evidence preservation and document productions.
