**ORDER**

WHEREAS, on December 9, 2008, the Special Master issued a Report and Recommendation Regarding Duration of Depositions of Current and Former Employees of Nonparty Dell Inc. (DM 20) (D.I. \_\_\_\_\_ in C.A. No. 05-485, D.I. \_\_\_\_\_ in C.A. No. 05-441, and D.I. \_\_\_\_\_ in MDL No. 05-1717); and

WHEREAS, the Special Master entered an Order (D.I. \_\_\_\_\_ in C.A. No. 05-485, D.I. \_\_\_\_\_ in C.A. No. 05-441, and D.I. \_\_\_\_\_ in MDL No. 05-1717) modifying the time for parties to file objections to the Report and Recommendation which has been signed by the Court; and

WHEREAS, Dell, Inc. filed Objections to the Report and Recommendation (D.I. \_\_\_\_\_ in C.A. No. 05-485, D.I. \_\_\_\_\_ in C.A. No. 05-441, and D.I. \_\_\_\_\_ in MDL No. 05-1717); and

WHEREAS, in response to Dell's Objections, Advanced Micro Devices, Inc. and Class Plaintiffs, filed a letter with the Court (D.I. \_\_\_\_\_ in C.A. No. 05-485, D.I. \_\_\_\_\_ in C.A. No. 05-441, and D.I. \_\_\_\_\_ in MDL No. 05-1717) (i) standing on their original briefs and accompanying evidence filed before the Special Master and on the arguments made by counsel for AMD and Class Plaintiffs during the hearing before the Special Master on December 8, 2008, and (ii) adopting the analysis and conclusions of the Special Master's Report and Recommendation.

NOW, THEREFORE, the Court having considered the Special Master's Report and Recommendation, the Dell witnesses' objections thereto, the original briefs and accompanying evidence filed by AMD and Class Plaintiffs, and the transcripts pertaining to this matter, IT IS HEREBY ORDERED that Dell's Objections and **OVERRULED** and the Special Master's Report and Recommendation (DM 20) (D.I. \_\_\_\_\_ in C.A. No. 05-485, D.I. \_\_\_\_\_ in C.A. No. 05-441, and D.I. \_\_\_\_\_ in MDL No. 05-1717) is **ADOPTED**.
