**STIPULATION AND [PROPOSED] ORDER EXTENDING AMD'S TIME TO
RESPOND TO INTEL'S MOTION FOR PROTECTIVE ORDER (DM 27)**

WHEREAS, on March 18, 2009, Intel filed an application for a protective order requiring AMD to return and refrain from further use of the European Commission's Statement of Objections (DM 27); and

WHEREAS, on March 20, 2009, the Special Master informed the parties that he would invite the European Commission to express its views on the issues implicated by Intel's application and by AMD's February 9, 2009 application for letters rogatory (DM 26);

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, subject to the approval of the Court, that AMD's response to Intel's application for a protective order shall be due three (3) days from the date that the European Commission either responds to the Special Master's invitation to provide its views on the issues identified or indicates that it will not so respond.


