STIPULATION AND ORDER MODIFYING

CASE MANAGEMENT ORDER #11 AND RESOLVING DM9

WHEREAS, on September 8, 2009, the Court entered Case Management Order No. 11, extending the deadlines for service of Intel's expert witness reports and AMD's rebuttal expert witness reports in the AMD Action;

WHEREAS, on October 6, 2009, AMD served corrections to the work papers supporting the expert witness reports of Dr. Daryl Ostrander, Dr. Thomas Lys and Dr. Mark Watson, which resulted in corrections in Dr. Ostrander's report and corresponding corrections in the reports of Dr. Lys and Dr. Watson as a result of the corrections by Dr. Ostrander;

WHEREAS, on October 8, 2009, Intel filed a motion (DM9) seeking an extension of time to respond to AMD's corrected expert witness reports, which motion AMD opposed;

WHEREAS, Intel seeks additional time to respond to AMD's corrected reports, and AMD is agreeable to extending Intel's time to serve one of its expert reports and certain supplemental reports that may be necessary;

WHEREAS, AMD seeks additional time to respond to Intel's reports, and Intel is agreeable to extending AMD's time to serve certain rebuttal reports; and

WHEREAS, the parties have previously agreed to extend Intel's deadline for submitting Dr. Snyder's damages report to October 26, 2009 and to extend AMD's deadline for all rebuttal reports that AMD believes in good faith are affected by Dr. Snyder's report to December 4, 2009;

NOW, THEREFORE, IT IS HEREBY STIPULATED BY AND AMONG AMD AND INTEL, THROUGH THEIR RESPECTIVE COUNSEL, AND SUBJECT TO THE APPROVAL OF THE COURT, AS FOLLOWS:

1. The deadlines set forth in Case Management Order No. 11 for service of expert witness reports shall be extended as follows:

a. Intel's deadline for serving its expert report responding to Dr. Ostrander's report is extended to November 2, 2009 (the "Ostrander Response");

b. On or before November 2, 2009, Intel may serve supplements to any previously served expert report by an expert whose opinions rely on or are affected by the Ostrander Response or the corrections in Dr. Ostrander's work papers or the corresponding corrections in the reports and work papers of Dr. Lys and Dr. Watson; and

c. AMD's deadline for serving Dr. Ostrander's rebuttal report and the rebuttal report of any other AMD expert whose opinions rely on or are affected by Dr. Ostrander's rebuttal report is extended to December 11, 2009.
